

SUMMARY ANNUAL REPORT

BROTHERHOOD OF LOCOMOTIVE ENGINEERS AND TRAINMEN

This is a summary of the annual report for the Brotherhood of Locomotive Engineers and Trainmen Disability and Welfare Benefit Trust Fund, 30-0262584/501, for 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The plan has a contract with Sun Life Assurance Company of Canada to pay certain claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$5,618,758.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$17,757,100 as of 12/31/2023, compared to \$15,462,988 as of 01/01/2023. During the plan year the plan experienced an increase in its net assets of \$2,294,112. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$8,350,450, including employer contributions of \$4,930,020, employee contributions of \$888,655, gains of \$119,602 from the sale of assets, earnings from investments of \$2,410,333, and other income of \$1,840. Plan expenses were \$6,056,338. These expenses included \$437,682 in administrative expenses and \$5,618,656 to insurance carriers for the provision of benefits.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes, if any, will be included as part of that report. The charge to cover copying costs given above does not include a charge for copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan at 7061 East Pleasant Valley Road, Independence, OH 44131 and at the U.S. Department of Labor in Washington, DC, or obtain a copy from the U.S. Department of Labor upon payment of copying costs.
